Objectives and Investment Policy

The investment objective of the Fund is to achieve a return for investors over the medium to long term based on a combination of capital growth and income and with a low volatility level.

The fund seeks to meet its objective through gaining exposure to a global portfolio of assets, including property, cash and various types of investment in companies and governments, the relative proportions of which ("asset allocations") are determined by the fund's investment manager using forecast asset volatility information provided by EValue Investment Solutions ("EValue"), a third party company that estimates the riskiness of investment types by modelling how they might be likely to behave over certain periods of time.

EValue asset allocations each reflect one of seven risk profiles, ranging from level 1, which reflects the risk of holding cash in bank accounts, to level 7, which is the riskiest profile in their range. The Fund is ranked at level 2, based on their predictions over a 15 year period.

The EValue model works differently from that used to generate the Synthetic Risk and Reward Indicator shown elsewhere in this document, so the two rankings may differ.

The Fund is actively managed and is not managed with reference to a benchmark index.

The Fund invests primarily (70% of its portfolio) in a blend of 'active' funds, whose managers aim to beat the performance of a benchmark and 'passive' funds, which aim to track the performance of an index. Underlying funds may include funds managed by Architas or its associates. We select active funds based on their consistency of investment returns, the risks related to the investment strategy, the strength of the investment process, and the stability of the fund's management team. Passive funds are selected on the basis of their accuracy in tracking the performance of their associated index. Active funds will be preferred when we believe that the potential returns outweigh any additional cost.

Underlying funds may invest in a wide range of financial instruments, including shares, shares of investment trust companies, tradable debt (bonds) issued by companies, governments and other institutions, debt instruments which can easily be converted into cash (money market instruments), freely transferrable rights to buy other investments at a future date (warrants) and financial contracts that derive their values from those of other investment instruments or indices (derivatives). The underlying funds may invest in the UK or overseas, including in emerging markets.

The Fund may also invest directly in the above financial instruments when there are specific benefits in doing so. The Fund may use derivatives with a view to: generating investment returns; reducing risk or costs; or generating additional capital or income in a manner consistent with the Fund's risk profile. The Fund may use derivatives for investment purposes as well as for Efficient Portfolio Management. For example, where it may not be economical or efficient to use investment funds, the Fund may use derivatives to adjust its exposure to foreign currencies or asset classes, or to track the performance of particular financial indices. The Fund may not invest in derivatives if to do so would be inconsistent with the Fund's risk profile.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

If you hold income shares, we will pay you any income earned from the Fund's investments on a semi-annual basis. If you hold accumulation shares, we will automatically include income earned in the value of your shares.

You may sell your investment on a daily basis.

The base currency of the Fund is GBP.

Risk and Reward Profile

The following are additional risks not covered by the risk and reward category:

Credit Risk - Bonds: The Fund may invest in bonds which provide a fixed or variable return and which are a form of loan, the value of which depends on the issuer being able to make its payments. There is a risk that the issuer will fail to do so. Although the Fund generally invests in bonds with high ratings, a high rating does not guarantee an issuer's ability to pay.

Credit Risk - Non-Investment Grade Bonds: The Fund may invest in bonds issued by entities considered to be more likely to default (non-investment grade). If an issuer does default this may result in the Fund and your investment suffering a loss.

Counterparty Risk: The insolvency of any institutions providing services such as safekeeping of assets or acting as counterparty to derivatives or other instruments, may expose the Fund to financial loss.

Fund of Funds - Liquidity Risk: The Fund invests in other funds and its liquidity depends upon the liquidity of those underlying funds. If underlying funds suspend or defer the payment of redemption proceeds, the Fund's ability to meet redemption requests may also be affected.

Derivatives Risk: Some of the underlying funds may invest in derivatives, which can, in some circumstances, create wider fluctuations in their prices over time.

Interest Rate Risk: Fluctuations in interest rates may affect the value of the Fund and your investment.

Charges

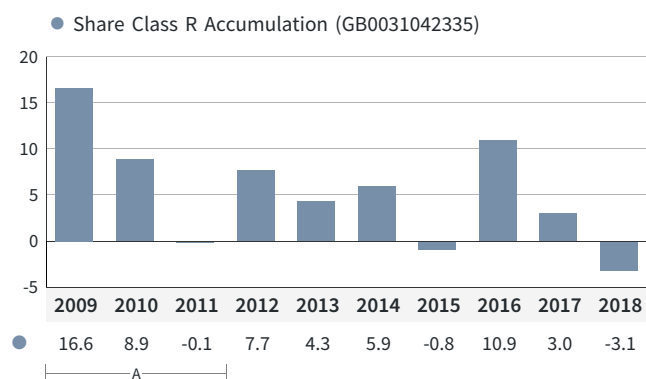
The entry and exit charges shown are maximum figures. In some cases, you might pay less - you can find this out from your financial adviser or distributor.
